

REPORT OF THE COMMITTEE




A meeting of the Committee constituted by the Vice-Chancellor Notification No.1-183/98-HPU (Acad.) Vol-VI, dated 27th June, 2008 for making recommendations on the Inspection Report submitted by the Inspection Commission for the grant of affiliation/extension of affiliation to be granted by the University for the existing/new courses being run on year to year basis by the Govt./Govt. professional institutes/colleges was held on 18.5.2009.


The Committee considered the Inspection Report of Shanti-Arya Institute of Education and Training, Rampur Keonthal, Shimla-171011 to run B.Ed. course 2009-10 and is of the opinion that extension of affiliation to run B.Ed. course by college for 2009-10 may be granted with the following observations:

1. Cabins need to be erected in the language lab. The lab also needs to be shift to a separate room as it is presently established in one part of the Computer lab
2. Latest editions of library books relating to B.Ed. course also need to be procured.
3. Handicam and LCD projector should be acquired by the college to make microteaching programme more effective and meaningful.



with cabins for proper functioning of the lab. The steps may be taken to complete during the next academic session.

8. The ET lab. has OHP, TV and VCR. However, the college is advised to acquire Har LCD projector so that microteaching programme is made more effective and meaningful.
9. The library has 4952 books in all as per accession register maintained in the library and physical verification made by the Inspecting Team. It may however be pointed out the college has not added books to its library during the current academic session. The college has been advised to procure latest editions of few of the books relating to B.Ed. Course. The number of journals subscribed by the college is Nine and all journals are relevant to the B.Ed. Programme.
10. There are in all seven teachers and two instructors employed by the College, out of which two are on regular basis and one on fixed salary. In addition to these two instructors are employed on time basis. Thus, there is sufficient teaching faculty to run the course. The college has provided the facility of CPF contribution to its regular teachers who have completed their probation period. The committee also interacted with the teaching faculty and found that the faculty is satisfied with their salary and working condition.
11. The college has maintained cashbook, ledgers, service books of the staff and stores properly.

On the basis of the above observations the Committee recommends that the extension of the college be allowed to the college for running B.Ed. Course during the session 2009-10 with an intake of 100 students.
